- 2. (A) **Part I Techno-Commercial bid** will be opened electronically on specified date and time as given in the NIT.
  - (B) **Part II Price bid** will be opened electronically of only those bidder(s) whose Part I Techno-Commercial Bid is found to be Techno-Commercially acceptable by RBI, NEW DELHI. Such bidder(s) will be intimated the date of opening of Part II Price bid, through valid e-mail confirmed by them.
- 3. All entries in the tender should be entered in online Technical & Commercial Formats without any ambiguity.

#### 4. Special Note towards Transaction fee:

The vendors shall pay the transaction fee using "Transaction Fee Payment" Link under "My Menu" in the vendor login. The vendors have to select the particular tender from the event dropdown box. The vendor shall have the facility of making the payment either through NEFT or Online Payment. On selecting NEFT, the vendor shall generate a challan by filling up a form. The vendor shall remit the transaction fee amount as per the details printed on the challan. #### Section II

# General Instructions to Contractors and Special Conditions of Contract (To be read in relevance to e-tendering process only)

#### 2.1 Scope of work

The tenderer shall supply sufficient number of Cars/Utility Vehicles for Bank's representative / police escort accompanying fresh / soiled note remittances, enabled with Global Positioning System (GPS) from:

- i. Railway station / Airports / any place or any Issue Office of RBI to the RBI, New Delhi
- ii. RBI, New Delhi to the currency chests located under its jurisdiction or in NCR of Delhi and;
- iii. Currency chests located under the jurisdiction of RBI, New Delhi(i.e., in NCT of Delhi) to any Issue Office of RBI.

#### 2.2 Eligibility for the tenderer

The tenderers must be reputed, experienced, resourceful, and financially sound and licensed entity (company/partnership/proprietary firm, etc.) having:

- i. Should have minimum 5 years of experience of executing similar services (during last 5 years ending last day of month previous to the one of which applications are invited).
- ii. Minimum average annual turnover of at least 100% of estimated cost of the contract i.e., ₹13,52,000/- during each of the last three financial years, ending 31<sup>st</sup> March of the previous financial year (i.e., March 31, 2024), duly supported by audited financial statements.
- iii. Positive net worth as per the latest audited balance sheet. The tenderers shall submit solvency certificate duly certified by the bank.
- iv. Approximately 6 to 10 GPS (Global Positioning System) enabled vehicles having high ground clearance, sufficient space in the vehicles to be able to carry firearms.
- v. The bidder must have experience of having successfully completed similar works during last

5 years ending last day of month previous to the one of which applications are invited should be either of the following:

- (a) Three similar completed services each costing not less than the amount equal to 40% (forty per cent) of the estimated cost (i.e., Each individual completed similar service under an individual contract should not be less than ₹5,40,800/-); or
- (b) Two similar completed services each costing not less than the amount equal to 50% (fifty per cent) of the estimated cost (i.e., Each individual completed similar service under an individual contract should not be less than ₹6,76,000/-); or
- (c) One similar completed service each costing not less than the amount equal to 80% (eighty per cent) of the estimated cost (i.e., Each individual completed similar service under an individual contract should not be less than ₹10,81,600/-)

#### Note:

"Similar Services" will mean services provided by the tenderer for Supply of Cars/Utility Vehicles to Central/State Government/PSUs/ Nationalized Banks/Reputed Organizations. The decision of Reserve Bank of India, New Delhi on whether the past work experience of any tenderer qualifies as work of similar nature or not as necessitated under Eligibility Criteria given in the tender document shall be final and binding on all the tenderers.

- vi. The tenderer shall have Permanent Account Number (PAN) and GSTN number, as applicable to discharge the duties.
- vii. In case of successful award of the contract, the tenderer shall have an Office/ local representative office in NCT of New Delhi for execution of the contract, for signing of all documents; providing of vehicles to carry out the scope of work described in the tender.
- viii. The tenderer shall maintain an account with any of the scheduled commercial banks. The name of the bank and nature of account maintained should be furnished to the Bank.

Note: The tenderers shall submit documentary evidences i.e., client certificate in support of their

claims of possessing the required qualification/ eligibility. Further, if the quality of the services rendered by the bidder is found unsatisfactory based on feedback/client reports received from other offices of RBI or other entities, it shall constitute ground for disqualification/ rejection of their bid.

Part II Price bid shall be opened electronically of only those bidder(s) whose Part I Techno-Commercial Bid is found to be Techno-Commercially acceptable by RBI, New Delhi. Such bidder(s) shall be intimated date of opening of Part II Price bid, through valid e-mail provided by them.

#### 2.3 Issue and Submission of Tender

Tender for "Providing Vehicles to Police Escort for accompanying remittances" shall be uploaded through MSTC website strictly in accordance to the procedures prescribed in "Important Instructions Regarding E-tender" of this document & will be remain open to the tenderer for participation before March 20, 2025 at 14:00 hrs under any circumstances whatsoever.

#### 2.3(a) Part I – Technical & Commercial/Scope of works and Commercial conditions

- a) Estimated cost of work is ₹13.52 Lakhs per annum, however the actual amount may vary.
- b) Part-I shall contain the unpriced tender consisting of scope of works as specified, specifications of an item of works, documents and commercial terms and conditions etc. Earnest Money shall be submitted through NEFT/Demand Draft/ Banker's Cheque or Bank Guarantee.
- c) Part-I of the tender as submitted shall contain the following unless otherwise stated separately in this document:
- (i) Earnest Money Deposit (EMD) shall be deposited through NEFT in favour of Reserve Bank of India, New Delhi in the A/c 186003001 & IFSC – RBIS0NDPA01 on or before the date and time given in NIT. EMD may also be submitted in the form of Demand Draft/ Banker's Cheque or Bank Guarantee issued by a Scheduled Bank drawn in favour of the Reserve Bank of India.

- (ii) Power of Attorney/authorisation with the seal of the company/firm in the name of the person signing the tender documents.
- (iii) Any other technical information the tenderer wishes to furnish.
- (iv) Performance Bank Guarantee as per format given in <u>Annex-II</u> towards security deposit to be submitted by successful tenderer within 10 days from the date of award of work.
- d) The Tenderers are advised to visit the site and get acquaint themselves of the site conditions before tendering.
- e) The tenderers are advised to submit the tender based strictly on the General Conditions of the Contract and scope of works as specified in the tender documents, and not to stipulate any deviations. If acceptance of the terms and conditions given in the tender documents has any price implications, the same would be considered to have been included in the quoted price. Tender containing deviations from the terms and conditions is liable to be rejected.
- f) All information, correspondence letters shall be addressed to The Regional Director, Issue Department, Reserve Bank of India, New Delhi.

#### 2.3(b) Part II - Price Bid

- (a) The Tenderers are advised to visit the site/s of work/s / activities, viz. Bank premises, railway stations and acquaint themselves with the site conditions before submission of tender.
- (b) This part shall contain prices in <u>Indian Rupees only</u> and shall be opened for only those tenderers who fulfill the minimum eligibility criteria and have a satisfactory track record of providing similar services at other RBI Offices or other organizations. Changes of terms and conditions and technical deviations, if any, found in Part II of the tender will not be considered and such tender will be treated as null and void. Date and time for opening of Part -II shall be informed to eligible tenderers separately through e-mail provided by them.
- (c) Rates should be quoted in **Indian Rupees only**. No request for any change in rate or conditions after the opening of the part II tender will be entertained.

- (d) The rates quoted shall be based on the Part-II of tender and shall be firm and binding without any **Escalation** whatsoever till the entire Contract period.
- (e) For any item, if the rate and amount do not tally with respect to the bill of quantities, then the amount arrived on the basis of quoted rates shall only be acceptable and in case of variation of rates in the original and duplicate, the lower of the two rates will be considered for arriving at the total amount for that item.

#### 2.4 Opening of Tender:

The Bank shall open the Tender electronically on the notified date.

#### 2.5 Pre-Bid Meeting

- **2.5.1** A pre-tender briefing meeting of the intending tenderers will be held on **March 07,2025 at 16:30 hrs** at the Conference Room, Issue Department, RBI, New Delhi to clarify any point/doubt raised by them in respect of the tender. No separate communication will be sent for this meeting. It is recommended that all interested tenderers attend the Pre-Bid meeting in their own interest.
- 2.5.2 If the bidders have any doubt as to the meaning of any portion of the general conditions, or the special conditions or the scope of the work or any other matter concerning the tender, she/he shall in good time, before the scheduled date and time of Pre-bid meeting, submit the queries to the RBI, via e-mail ID at <a href="mailto:issuenewdelhi@rbi.org.in">issuenewdelhi@rbi.org.in</a> or in writing, addressed to the Tender Inviting Authority, in order that such doubts may be clarified authoritatively during Pre-bid meeting and shall be conveyed to all the bidders in due course.
- **2.5.3** Any tender received with any deviation/ Condition is liable for rejection. No further doubts/clarifications shall be entertained after the pre-bid meeting.

#### 2.6 Validity of Tender

**2.6.1** The tender shall be valid for acceptance by the Bank for a period of 90 days from the date of opening of Part -I of tender and shall be extended by such period as may be mutually agreed to. In case of withdrawal of tender by the tenderer during the period, the Bank shall forfeit the Earnest

Money Deposit. The rates quoted by the tenderer shall remain firm during the period of contract i.e., April 01, 2025 to March 31, 2026.

#### 2.7 Lowest Tender Not Necessarily to Be Accepted

- 2.7.1 Lowest among the quoted rates will be considered L-1 and work will be awarded to them, in case the lowest rate appears to be reasonable taking into account the prevailing market conditions. In case of two or more tenderers becoming lowest, i.e., quoting the same amount, then discount on already quoted amount shall be obtained in sealed envelope from such tenderers and lowest among the quoted rates will be considered as L-1.
- **2.7.2** The Bank is not bound to accept the lowest or any tender and reserves the right to reject any or all the tenders, either in whole or in part, without assigning any reason.
- **2.7.3** The tenderer whose tender is not accepted shall not be entitled to claim any costs, charges, damages and expenses of any incidental to or incurred by him through or in connection with his submission of tenders, even though the Bank may elect to modify/withdraw the tender.

#### 2.8 Earnest Money Deposit

- 2.8.1 Interested tenderers shall pay as Earnest Money Deposit(EMD), a sum of ₹27,040/- to be deposited through NEFT/Demand Draft/ Banker's Cheque or Bank Guarantee on or before the date and time given in NIT. If the Tenderer, after submission of the tender, deviates from his/their offer or modifies the terms and conditions thereof or withdraws his/their bid, such tenders shall be liable to be cancelled and the EMD shall be liable to be forfeited. Bank will not pay any interest on EMD.
- 2.8.2 EMD submitted through NEFT should reach us before 12:00 hrs on March 20, 2025. In case the EMD is submitted through Demand Draft/ Banker's Cheque or Bank Guarantee, the original instrument should be sent to us sufficiently in advance to reach us before 12:00 hrs on March 20, 2025. A scanned copy of the physical instrument should also be sent to us through email id <a href="mailto:issuenewdelhi@rbi.org.in">issuenewdelhi@rbi.org.in</a> before 12:00 hrs on March 20, 2025. In case the physical EMD instrument (Demand Draft/ Banker's Cheque or Bank Guarantee) is not received by us or the scanned copy of Demand Draft/ Banker's Cheque or Bank Guarantee towards EMD is not received.

by us before 12:00 hrs on March 20, 2025, the tender shall be considered to be rejected.

- **2.8.3** Any tender without depositing the EMD is liable to be rejected. Further, in case any tenderer submits EMD after the date and time indicated in the NIT, its tender will be considered null and void and will not be considered for opening of Part I.
- 2.8.4 The EMD of successful tenderer shall stand discharged on production of a Performance Bank Guarantee of ₹67,600/- towards Security Deposit within 10 days of award of work in the enclosed format (Annex II) as per details given on para 2.10 of this tender document.
- 2.8.5 Earnest Money deposit of all tenderers other than successful tenderer shall be refunded on expiry of bid validity (including extended validity) or on award of work to the successful tenderer whichever is earlier.
- **2.8.6** Should the Invitation to Tender be withdrawn or cancelled by the Bank, which shall have the right to do so at any time, the EMD will be discharged.
- **2.8.7** Should the successful Tenderer fail to furnish the Security Deposit in the form of PBG, the EMD submitted by the tenderer shall be forfeited without prejudice to his being liable for any further loss or damage incurred in consequence, by the Bank.

#### 2.9 Commencement / Renewal

- **2.9.1** On receipt of intimation from the Bank of the acceptance of his / their tender(s), the successful tenderer shall be bound to execute and implement the contract. The successful tenderer shall sign an agreement with the Bank within a week in accordance with the conditions in tender document and the schedule of rates. The cost of stamp paper will be borne by the successful tenderer.
- **2.9.2** Contract shall be valid for one year at a time (i.e. 1st April, 2025 31st March, 2026) which can be extended by the Bank at its opinion for a further period of two years, one year each at a time with/ without any variation in the terms and conditions, subject to satisfactory performance of the contractual terms and conditions. Thereafter fresh bidding for the new tender for the said service may be undertaken.

- **2.9.3** When the period of the contract is about to expire, the matter of extension of the contract may be considered by the Bank. Three months before the expiry of the existing contract, the contractor shall provide in writing to the Bank, whether he is willing to renew the contract for a further period on the existing terms and conditions.
- **2.9.4** In case of an increase in charges solicited by the contractor for renewing the contract, the Bank may examine the reasonableness of the increase solicited and may, at its opinion, undertake negotiation with the contractor regarding the increase solicited.
- 2.9.5 The successful tenderer will have to submit a list of drivers whom he would engage when the contract is finalized and should furnish their complete names and addresses along with a recent passport size photograph and attested photocopy of his driving license, a character certificate and police verification done before the commencement of the contract.

#### 2.10 Performance Bank Guarantee

- 2.10.1 A Performance Bank Guarantee (PBG) for an amount equal to 5% of the estimated contract value i.e., ₹67,600/- shall be deposited within 10 days after the issue of notification of award by RBI.
- 2.10.2 The PBG shall be valid for the entire period of currency of contract for due fulfilment of the contractual obligations by the contractor. Submission of PBG shall be ensured as stipulated in the tender. If the contract is renewed, the contractor will arrange to provide an extended Performance Bank Guarantee accordingly.
- 2.10.3 In case of delays in submission in unavoidable circumstances, charges for the delay in submission of PBG will be recovered from the bills of contractor at "Bank Rate" as published in accordance with section 49 of the Reserve Bank of India Act, 1934.
- **2.10.4** No interest shall be payable on the amount of PBG.
- **2.10.5** Upon increase in the value of contract due to increase in the number of vehicles required, the Bank reserves the right to increase the amount of bank guarantee in proportion to the contract amount and the contractor shall be bound to provide bank guarantee of additional amount.

#### 2.11 Duties of the contractor:

It shall remain the contractor's responsibility to successfully execute the contract till the completion of validity period. In case contractor fails to carry out the assigned work, his/her PBG shall be invoked. Further, the contractor has to indemnify the Bank from any type of loss due to any negligence on its part and for which the Bank is not responsible.

- (i) The Contractor shall, at all times during the Contract Period, on the receipt of written or verbal requisition to that effect from the General Manager / Deputy General Manager, Reserve Bank of India, Issue Department, New Delhi or any of his subordinate officer(s), supply adequate number of vehicles for Police escorts for accompanying remittances. Such requisition may be delivered to the contractor by means of telephone or mobile phone or e-mail or fax etc. The requisition notice may be cancelled by the Bank by issuing another notice, orally or in writing not less than three hours before the time fixed for transport of note boxes. In such case the Bank shall not make any payment to the contractor by way of remuneration compensation etc.
- (ii) In urgent cases, certified by the General Manager/DGM-in-charge, Issue Department of the Bank, requisition with thirty minutes notice in lieu of twelve hours' notice, may be made by the Bank and shall be complied with accordingly by the contractor.
- (iii) The notice so given shall be complied with, even if it requires working beyond ordinary business hours or on a day/days declared as Public Holiday/s under the Negotiable Instruments Act, 1881 including Saturday and Sunday or any other extant statute / provision applicable in this respect.
- (iv) The contractor shall not, in any circumstances, cause travel any other person in the vehicles other than Bank representatives and Police Escorts.
- (v) The tenderer shall be required to obtain necessary route permits and pay all relevant taxes on his/her own.
- (vi) It should be duty of the Contractor to issue uniforms/ photo identity card to his drivers.
- (vii) The contractor shall not assign the contract onwards. He/She shall not sublet any portion of the contract except with the prior written consent of the Bank. In case of breach of this condition, the

Bank may rescind the contract and invoke PBG.

- (viii) In case of any breakdown of vehicles, the contractor shall be able to provide services of alternate Cars/Utility Vehicles of similar specifications so that the remittance of the treasure is not delayed. In case the contractor fails or delays such arrangement and the Bank makes such arrangement from market, the Bank shall be entitled to recover the cost of such arrangement from the contractor from the charges/bills to be paid to the contractor.
- (ix) The contractor shall ensure that the vehicles are having valid permission issued by RTO concerned, Registration papers, permit, PUC certificate, Fitness Certificate, tax paid up to date, required Insurance cover, etc. to the vehicles. The drivers must have valid driving license. The contractor will indemnify and keep the Bank indemnified against any loss, costs, charges and expenses incurred or suffered by the Bank on account of lack of said permit, license, certificates, etc. The contractor shall ensure adherence to all state government/central government instructions/guidelines w.r.t vehicles being provided which inter alia includes adherence to GRAP norms/ban on plying of diesel/petrol vehicle of prescribed age etc.
- (x) The Bank shall have the right to inspect or arrange inspection of the vehicles deployed by the contractor for the work at any time and declare any vehicle/ equipment unsafe and ask for its immediate withdrawal from the operation. The contractor shall ensure prompt/ immediate compliance of the same.
- (xi) The vehicles supplied by the contractor shall be less than 5 years old and must be roadworthy and in good condition. These vehicles shall either be owned or leased by the contractors. In case of leased vehicles, the lease of vehicles shall not expire during the contract.
- (xii) The work of the Bank should be carried out in a proper, careful, expeditious and efficient manner. The tenderer shall be required to work in close co-ordination with the Delhi police.
- (xiii) The operations to be entrusted to the Contractor will be time-critical. Therefore, the contractor should supply sufficient and adequate number of vehicles at such notice as may be specified by the Bank.

- (xiv) It is imperative on the part of the Contractor to get antecedents and character of all the drivers engaged by him verified by the Police Department before the commencement of the contract. The drivers should possess valid driving license.
- (xv) The contractor shall ensure that the Vehicle sent to accompany the closed trucks carrying remittance of notes/ coins reach simultaneously with the trucks at all the specified destinations.
- (xvi) The contractor will adhere to the relevant provisions of IS policy of the Bank.

#### 2.12 Payments and Taxes

- **2.12.1** The payment will be made on monthly basis after the submission of bills for each consignment complete in all respects.
- 2.12.2 The contractor shall be paid charges for services rendered at the rates mentioned in the Schedule to this Agreement. The said charges offered are fixed and cannot be enhanced on any ground for the entire contract period and no additional charges shall be claimed by the contractor.
- 2.12.3 The contract price shall be all inclusive consisting of fixed and operating charges and based on the Scope of Work, vehicle being supplied and also include inter alia, Driver's salary/uniform/food/allowances etc., Employees' State Insurance Corporation (ESIC) payment, Employee Provident Fund (EPF) payment, Bonus payment, Gratuity, insurance, profit & overtime wages, if any, taxes & levies, parking charges, toll gate fees & all other charges. It is obligatory on the part of the Contractor to pay wages which should not be less than minimum wages as prescribed by the appropriate authority under the Minimum Wages Act, to his contract labour, retrenchment compensation, notice pay, gratuity and bonus as payable and the Contactor is liable to provide all welfare measures to the contract labour as required by the prevailing laws in this regard.
- **2.12.4** The Bank reserves the right to recover/enforce recovery of any overpayments detected after payment as a result of post-payment audit or technical examination or by any other means.
- 2.12.5 All compensations or other sums of money payable by the contractor to the Bank under the terms of the contract shall be deducted from the dues payable or becoming payable to the

contractor or by invoking the Performance Bank Guarantee as deemed fit by the Bank.

2.12.6 In the event of any dispute as to whether any liability has arisen hereunder, the decision of the Regional Director/Office-in-charge, Reserve Bank of India, New Delhi shall be final and binding on both parties. For all types of litigations arising under the Contract, Delhi Courts will have exclusive jurisdiction.

#### 2.13 Insurance

2.13.1 The contractor shall take all insurances at his cost to cover all kinds of risks associated with the vehicles/third party. These policies shall be valid for the accepted contract period. If the Contractor does not provide these policies, the RBI reserves the right to take the above insurance policies themselves and recover the cost thereof from the bill of the Contractor.

#### 2.14 Rights of the Bank

- **2.14.1** The Bank reserves the right to extend the period of tender availability and / or the date of opening of the bids.
- **2.14.2** The Bank reserves the right to accept or reject any / all applications or annul the process of qualification without any liability and/or assigning any reason thereof.
- 2.14.3 In case of two or more tenderers becoming lowest, i.e., quoting the same amount, Bank reserves the right to obtain discount on already quoted amount in sealed envelope from such tenderers and lowest among the quoted rates received through sealed envelope will be considered as L-1.
- 2.14.4 The terms and conditions specified herein are indicative in nature and the same shall not restrain the Bank from imposing or requiring the Bidder to agree upon such further or other terms and conditions at the time of executing the agreement with the successful Bidder, or to alter, modify or omit the terms and conditions contained herein, as are considered necessary for the due and proper execution of the work being awarded under this Tender.
- 2.14.5 The Contractor or its agents / workers / drivers committing any breach of terms and conditions

mentioned herein and / or rendering unsatisfactory services, in the opinion of the Bank shall render itself liable for penalty and/or termination of the agreement forthwith without any notice or any compensation in lieu thereof.

**2.14.6** Without prejudice to above, the Agreement can be terminated with a notice of three months on either side, during the Agreement period.

#### 2.15 Dispute Resolution

- **2.15.1** It is to be duly noted that in case of any / all disputes on terms and condition of this tender, the English version of the tender document shall prevail (in case tender is issued in English and any other language simultaneously).
- 2.15.2 If a dispute of any kind arises between the Bank and the contractor/counterparty in connection with or arising out of the contract or the execution of the works, the parties must attempt to resolve it amicably by way of mutual discussions, in good faith, within a period of 30 days from the date on which any party gives the other party a notice to negotiate/engage in amicable discussions.
- 2.15.3 If an amicable settlement is not forthcoming within the aforesaid period, then the dispute shall then be referred to and finally resolved through arbitration or conciliation as per the Arbitration and Conciliation Act 1996, as amended from time to time. The award passed by the arbitrator shall be binding on the parties and shall apply to the contract.
- **2.15.4** Jurisdiction and Governing Law: The agreement shall be subject to the jurisdiction of the courts at **Delhi**. The agreement is governed by the laws of India.

#### 2.16 Force Majeure

2.16.1 Notwithstanding anything else contained in this document, neither party shall be liable for any delay in performing its obligations hereunder if such delay is caused by circumstances beyond its reasonable control [including without limitation any delay caused by the acts of governments, acts of God, natural or social calamities, strikes, riots in any region, network failure, terrorist attack, war (declared and undeclared)] provided however that any delay by the supplier of the Party so delaying shall not relieve that Party from liability for delay except where such delay is beyond the

reasonable control of the supplier concerned.

#### 2.17 Disclaimer

- 2.17.1 Though adequate care has been taken while preparing this document, the tenderers shall satisfy themselves that the document is complete in all respects. Intimation of any discrepancy shall be given to this office immediately. If no intimation is received from any tenderer within seven (7) days from the date of NIT, it shall be considered that this document is complete in all respects.
- **2.17.2** The Bank reserves the right to modify, amend or supplement this document including all formats and Annexures.
- 2.17.3 While this document has been prepared in good faith, neither the Bank nor their employees or advisors make any representation or warranty, express or implied, or accept any responsibility or liability, whatsoever, in respect of any statements or omissions herein, or the accuracy, completeness or reliability of information, and shall incur no liability under any law, statute, rules or regulations as to the accuracy, reliability or completeness of this document, even if any loss or damage is caused by any act or omission on their part.

#### 2.18 Confidentiality Statement

- 2.18.1 The information contained in this Tender Document or subsequently provided to tenderer(s) whether verbally or in documentary form by or on behalf of the Bank or by any of its employees, shall be subject to the terms and conditions set out in this Tender Document and all other terms and conditions subject to which such information is provided.
- **2.18.2** The purpose of this tender document is to provide the tenderer(s) with information to assist the formulation of their proposals.
- 2.18.3 This Tender Document does not purport to contain all the information each tenderer may require.
- **2.18.4** This tender document may not be appropriate for all persons, and it is not possible for the Bank and/or its employees to consider the investment objectives, financial situation and particular

needs of each bidder who reads or uses this tender document.

- 2.18.5 Each tenderer should conduct its own investigations and analysis and should check the accuracy, reliability and completeness of the information in this tender document and where necessary obtain independent advice from appropriate sources.
- 2.18.6 The Bank and its employees make no representation or warranty and shall incur no liability under any law, statue, rules or regulations as to the accuracy, reliability or completeness of the tender document.
- **2.18.7** This document and the information provided therein are confidential and intended solely for the use of the Tenderer(s).

#### 2.19 Disqualification / Termination/ Penalty:

- 2.19.1 It will be treated as a serious misdemeanor in case a tenderer attempts to do any canvassing by or on behalf of the tenderer or to bring political or other outside influence with regard to the Bank's decision on scrutiny, comparison, evaluation and award of the contracts. In such case the tender of the tenderer shall be liable for rejection in addition to being blacklisted for a period of minimum one year extendable to 3 years. If such instances go undetected during the selection process but are detected subsequently, such disqualification will take place with immediate effect.
- **2.19.2** The contract may be terminated by either of the two parties for any reason, giving to the other party three months' notice in writing of such termination.
- **2.19.3** In event of any delay by the contractor in complying with any requisition issued by the Bank for supply of vehicles or any breach of instructions of the contract, considered by the General Manager/DGM-in charge, Issue Department, Reserve Bank of India, New Delhi to be grave enough to attract penalty, the aforesaid General Manager/DGM-in-charge in consultation with Regional Director/Officer-in-charge may impose a fine not exceeding Rs. 10,000 (Rupees ten thousand only) on the contractor for each instance.
- 2.19.4 In case of frequent or continued delay or in case of any breach by the Contractor of any of the provisions of this agreement, the Bank may terminate this contract with immediate effect by

giving intimation in writing by the General Manager / Deputy General Manager-in-charge, Issue Department with the approval of the Regional Director/Officer-in-charge on behalf of the Reserve Bank of India whether any penalty as herein before provided for such delay or breach has been imposed or not.

- **2.19.5** Continuation of the contract shall be primarily depending upon the performance of the contractor. In case the performance is found to be unsatisfactory at any point of time, the contract shall be terminated by giving three months' notice in writing.
- **2.19.6** If the Contractor failed to provide services for more than 3 occasions continuously, then the Bank has right to terminate the Contract with/ without giving any notice whatever may be the reason. In such case the transporter will not be entitled to claim compensation.

#### 2.20 Compliance with Statutes:

- **2.20.1** The contractor shall abide by all relevant laws in force in the country and state(s) concerned. The contractor shall indemnify the Bank from all types of legal implications due to any negligence on their part and for which the Bank is not responsible
- **2.20.2** The bidder must ensure adherence to various statutory provisions relating to labour, taxation, workmen safety, child and women labour, employment reservations etc. The bidder must be registered under appropriate authorities i.e must be registered with GST authorities/Income Tax/PAN/EPF/ESI authorities/Indian Registration Act 1908/Labour licence etc
- **2.20.3** The contractor shall abide by the provisions of the Motor Vehicle Acts and the rules of various States in force in the States concerned.
- **2.20.4** The Contractor should be registered under the Shop & Establishment Act and have necessary certificate to run tour & travel services. All the Cars/Utility Vehicles deployed by the Contractor for duty with the Bank's representative / police escort should be of commercial nature i.e., they must be registered with the RTO as a commercial vehicle. Documentary evidence of Taxi permits shall be provided to RBI as and when demanded.
- 2.20.5 The contractor shall make all applicable statutory payments like Minimum Wages, Employee

Provident Fund (EPF), Employees' State Insurance Corporation (ESIC), payment of Gratuity under Payment of Gratuity Act, 1972 to their deployed Workmen(Drivers) as per the notification published by Central Govt. / State Govt. whichever is higher from time to time, besides paying all other statutory payments.

- 2.20.6 The workmen should be paid the minimum wages under the Minimum Wages Act, 1948 and rules made thereunder. Besides, the workmen should be given Employees Provident Fund as per EPF Act, 1952, Bonus and / or dividends as per Payment of Bonus Act, 1965 and ESI under ESI Act, as applicable. In the absence of ESI, the contractor should undertake the liability under the coverage of Insurance such as Workmen's Compensation Insurance under Workmen's Compensation Act, 1923. The total premium shall be borne by the contractor. The contractor shall have a valid EPF Account for making EPF Contribution for its workmen. In case of any complaint regarding non-compliance of any statutory payments; the same shall be deducted from the bill without prejudice to the Bank's right to cancel the contract. The Contractor shall abide by all the statutory provisions of the Contract Labour (Regulation & Abolition) Act.
- **2.20.7** The Contractor shall maintain all records and legal documents updated as per prevailing statute and have to produce before the management / statutory authorities as and when asked for.
- 2.20.8 The contractor shall submit the salary disbursement statements against the signature of its employees assigned for the Bank's work for verification by the Bank on quarterly basis. If payment is made in cash, it should be in presence of the Bank's official under his signature. Alternatively, employees' bank account may be credited and bank statements indicating payment may be submitted.
- **2.20.9** The Principal Employer i.e. the Bank shall not be responsible for providing any employment benefits to the contract labour/workers/employees. In the event of the Bank as the Principal Employer being required/called upon to pay any amount to the contract labour/workers/employees engaged by the contractor due to lapse or default on his part in discharging his obligation in terms of any law in force, such amount would be recoverable by the Bank from the contractor as debt due to the Bank by the contractor.
- 2.20.10 The contractor shall be solely responsible for full compliance of the provision of the Sexual

Harassment at workplace (Prevention, Prohibition and Redressal) Act, 2013 by any mazdoor or other persons deployed by him/her for execution of the contract. In case of any complaint of sexual harassment against its employees/labour within the premises of Reserve Bank of India, the complaint will be filed before the Internal Complaints Committee constituted by the contractor and he/she shall ensure taking proper action under the Act in respect to the said complaint. The contractor shall be responsible for educating its employees about prevention of sexual harassment at work place and related issues.

- **2.20.11** Any complaint of sexual harassment from any aggrieved employee of the contractor against any employee of the Bank shall be taken cognizance of by the Regional Complaints Committee constituted by the Bank.
- **2.20.12** The contractor shall be responsible for any monetary compensation that may need to be paid in case the incident involves the employees of the contractor, for instance any monetary relief to the Bank's employee, if sexual violence by the employee of the contractor is proved.

#### 2.21 Non-Disclosure Clause:

The Contractor shall not disclose directly or indirectly any information, materials and details of the Bank's infrastructure/systems/equipment etc., which may come to the possession or knowledge of the contractor during the course of discharging its contractual obligation in connection with this agreement, to any third party and shall at all times hold the same in the strictest confidence. The contractor shall treat the details of the contract as private and confidential, except to the extent necessary to carry out the obligation under it or comply with applicable laws. The contractor shall not publish, permit to be published, or disclose any particulars of the works in any trade or technical paper or elsewhere without the previous written consent of the bank. The contractor shall indemnify the Bank for any loss suffered by the Bank as a result of disclosure of any confidential information. Failure to observe the above shall be treated as breach of contract on the part of the contractor and the Bank shall be entitled to claim damages and pursue legal remedies. The Contractor shall take all appropriate actions with respect to its employees to ensure the obligation of non-disclosure of confidential information under this agreement is fully satisfied. The contractor's obligations with respect to non-disclosure and confidentiality will survive the expiry or termination of this agreement

for whatever reasons.

#### 2.22 Corrupt or Fraudulent Practices

The Bank requires that tenderers, suppliers, contractors, interested in having business relationship with the Bank, observe the highest standard of ethics during the period of contract / engagement. In pursuance of this policy, the Bank:

- (a) defines, for the purposes of this provision, the terms set forth below as Prohibited Practices:
- (i) "Corrupt practice": making offers, solicitation or acceptance of bribe, rewards or gifts or any material benefit, in exchange for an unfair advantage in the procurement process or to otherwise influence the procurement process or contract execution;
- (ii) "Fraudulent practice": any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefits may be obtained or an obligation avoided. This includes making false declaration or providing false information for participation in a tender process or to secure a contract or in execution of the contract;
- (iii) "Anti-competitive practice": any collusion, bid rigging or anti-competitive arrangement, or any other practice coming under the purview of The Competition Act, 2002, between two or more bidders, with or without the knowledge of the Procuring Entity, that may impair the transparency, fairness and the progress of the procurement process or to establish bid prices at artificial, non-competitive levels;
- (iv) "Coercive practice": harming or threatening to harm, persons or their property to influence their participation in the procurement process or affect the execution of a contract;
- (v) "Conflict of interest": participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of Procuring Entity who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the Procuring Entity with an intent

to gain unfair advantage in the procurement process or for personal gain; and

- (vi) "Obstructive practice": materially impede the Procuring Entity's investigation into allegations of one or more of the above mentioned prohibited practices either by deliberately destroying, falsifying, altering; or by concealing of evidence material to the investigation; or by making false statements to investigators and/or by threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or by impeding the Procuring Entity's rights of audit or access to information
  - (b) will reject a proposal for award if it determines that the tenderer recommended for award has engaged in prohibited practices in competing for the tender in question;
  - (c) may declare a tenderer ineligible, either indefinitely or for a stated period, if, at any time, the Bank determines that the tenderer has engaged in prohibited practices in competing for, or in executing the contract.

### 2.23 Workmen Safety and Insurance

- a) The contractor shall alone be fully responsible for safety and security and insurance or life insurance of deployed Workmen (Drivers)
- b) The Bank shall not be liable for any compensation in case of any fatal injury/death caused to or by any manpower while performing/discharging their duties/for inspection or otherwise.
- c) The quoted rates shall not be less than the minimum wage fixed/notified by the state Government and shall include all statutory obligations.
- d) The contractor shall be liable for all kinds of dues payable in respect of all personnel provided under the contract and the Bank shall not be liable for any dues for availing services of the personnel.

The contractor shall ensure that persons to be deployed are not alcoholic, drug addict and not indulge in any activity prejudicial to the interest of the Bank. The contractor shall ensure to get the police verification for all the manpower deployed by them and the contractor should ensure

that the manpower deputed should bear good moral character.

#### 2.24 Documents required

All the bidders are required to include the following information and documents with their bids:

- a) Trade License
- b) Registration under shops & Establishment Act
- c) Copies of Registration Certificates of the Company/ firm/ agency issued by the relevant authority.
- d) Client feedback reports along with relevant work order.
- e) Audited annual financial statements for last 3 years i.e. F.Y. 2021-22, F.Y. 2022-23 and F.Y. 2023-24. (Indicating separately turnover through supply of vehicles on hire)
- f) Income Tax Returns for last three financial years i.e. F.Y. 2021-22, F.Y. 2022-23 and F.Y. 2023-24 (Indicating separately turnover through supply of vehicles on hire).
- g) Copies of applicable tax registrations. viz PAN, TIN, GST, etc.
- h) Copies of E.P.F Registration Certificate and E.S.I registration certificates, if any.
- i) Receipt for the payment of Earnest money Deposit (EMD) amount to the Bank.
- j) Information regarding any litigation, current or during the last five years, in which the bidder is involved, the parties concerned, and disputed amount
- k) Copies of work orders and experience in Services of a similar nature and size for each of the last five years, and details of services under way or contractually committed; and names and address of clients who may be contacted for further information on those contracts.
- Solvency Certificate issued by the tenderer's bankers specifically for this work for an amount equivalent to the estimated cost of the present work, indicating financial soundness of the tenderer.

- m) Details of the Bank Account held by them in a scheduled bank in India.
- n) List of vehicles with details viz. model, registration, insurance, date of purchase etc. along with copies of Registration Certificate, insurance, permits etc.
- o) Any other document/s required to be submitted, as mentioned above or as demanded by the Bank.

The Bank reserves the right to call for proof/ verification of any or all of the above mentioned particular

#### 2.25 Scrutiny/Evaluation

The tenders comprising two parts i.e., Part I on "scope of work and commercial conditions" and Part II on "Price Bid" shall be submitted through online bidding portal comprising of:

- (i) The tenders, comprising of two parts will be submitted by the tenderers. Part I comprising **scope of work and commercial conditions** to be submitted through online bidding portal comprising of:
  - a. Earnest Deposit Money in the form of NEFT for ₹27,040/-. No interest shall be paid on this deposit. EMD may also be submitted in the form of Demand Draft/ Banker's Cheque or Bank Guarantee issued by a Scheduled Bank drawn in favour of the Reserve Bank of India.
  - b. Power of Attorney/authorization with the seal of the company/firm in the name of the person signing the tender documents.
  - c. Documentary evidence and documents required to be submitted under the tender.
  - d. Undertaking stating that the tenderer is not willful defaulter to any bank/financial institution and there is no criminal case against the company/person
  - e. Masked Indicative Price Bid listing all the components as per Price Breakup Schedule without indicating any prices.
  - f. Any other information the tenderer wishes to furnish.

- (ii) Part-II comprising **Price Bid** of the tender to be submitted comprising of prices in Indian Rupees only with detailed break-up of price both in figures and words. No other enclosure is permitted in Part II. Change of terms and conditions and deviations, if any, found in Part II of the tender will not be considered and will be treated as null and void. The rates quoted shall be deemed to be for the finished work and shall be firm and binding without any escalation whatsoever.
- (iii) Part I of the tenders shall be opened in the presence of tenderers or their authorized representatives, who choose to be present.
- (iv) The tenders will first be scrutinized to determine whether they are complete and meet the essential and important requirements, conditions etc. as prescribed in the tender document, the tenders which do not meet the basic requirements, conditions etc. as prescribed in the tender document, are liable to be treated as unresponsive and ignored.
- (v) The tenders are advised to visit the site/s of work/s/activities, viz Railway Station and Bank premises and acquaint themselves with the site conditions before submitting bids.
- (vi) Price Bid (Part-II) of only such of those tenderer(s), who are found eligible after scrutiny of their Part -I of the tenders will be opened on subsequent working day or any future date informed by the Bank.
- (vii) The bank will award the contract to the tenderer whose Bid has been determined to be substantially responsive to the conditions mentioned in tender document and who has offered the Bid Price reasonable to the estimates considering the values of all the component of the contract for arriving at L1.
- (viii) Tenders will be evaluated on the basis of the terms and conditions already incorporated in the tender document, based on which tenders have been received and terms, conditions etc. mentioned by the tenderers in their tenders. No new condition will be brought in while scrutinizing and evaluating the tenders.
- (ix) Lowest among the quoted rates will be considered L-1 and work will be awarded to them. However, keeping in view the sensitivity of the work, the Bank shall be at liberty to not accept the

lowest bid or any tender and reserves the right to reject any or all the tenders at any stage of the tendering process, either in whole or in part, without assigning any reason.

(x) In case of two or more tenderers becoming lowest, i.e., quoting the same amount, then discount on already quoted amount shall be obtained in sealed envelope from such tenderers and lowest among the quoted rates will be considered as L-1.

#### Other Important Instructions

#### 2.26 Amendment to Tender document

- (i) At any time prior to the deadline for the submission of tender/ Bids, RBI may, for any reason, whether at its own initiative or in response to a clarification or query raised by a prospective Bidder, modify any part of the tender document by an amendment.
- (ii) The amendments would be made available on the website of RBI and MSTC website only.
- (iii) The Bidders are strongly advised to regularly visit the website <a href="www.rbi.org.in">www.rbi.org.in</a> and MSTC website to ensure that they are aware of the amendments, if any. The addendum (s)/ corrigendum, if any, issued will form part of the contract document.
- (iv) In order to afford prospective Bidders reasonable time for preparing their Bids after taking into account such amendments, the RBI may, at its sole discretion, extend the deadline for submission of Bids.

#### 2.27 Preparation of bid and Cost of bidding

The bidder must obtain for himself on his own responsibility and at his own expenses all the information which may be necessary for the purpose of making a tender and for entering into a contract and may inspect the site of the work (with prior permission of RBI) and acquaint herself/himself with all local conditions, nature of the work and all matters pertaining thereto.

#### 2.28 Signing of Bid, Power of Attorney

Each of the tender documents should be signed by the person or persons submitting the tender in

token of his/their acquainted himself/themselves with the General Conditions of Contract, Specifications and other terms and conditions etc. as laid down.

# 2.29 Undertaking /Declaration/Certification by the Bidder regarding country sharing land border with India

Compliance with the Rule 144(xi) of GFR 2017 inserted vide Office Memorandum (OM) F. No. 6/18/2019-PPD dated July 23,2020 by Public Procurement Division, Department of Expenditure, Ministry of Finance, Government of India, the Public Procurement Orders issued in furtherance thereto, and their subsequent revision shall be mandatory.

In this regard, bidder shall submit a copy of undertaking/Declaration/Certificate on their letterhead duly sealed and signed by the authorized signatory as per the format given in (Annex-III). If the Undertaking/Declaration/Certificate submitted by the bidder is found to be false, work order will be immediately terminated and legal action in accordance with law including forfeiting of Earnest Money Deposit/Security Deposit may be initiated and the Bank may also debar the bidder from participating in the tenders invited by the Bank in future.

#### Section-III

#### Scope of works

- 3.1 The contract is for a period of one year (April 01, 2025 March 31, 2026). The estimated value of the contract is ₹13.52 Lakhs per annum.
- 3.2 The selected Tenderer/s shall provide the vehicles as and when requisitioned by the Bank/by an official authorized by the Bank. The Contractor shall supply sufficient number of Cars/Utility Vehicles for Bank's representative / police escort accompanying fresh / soiled note remittances, having taxi permit as per the requirement of the Bank enabled with Global Positioning System (GPS) from:
  - (i) Railway station / Airports / any place or any Issue Office of RBI to the RBI, New Delhi
  - (ii) RBI, New Delhi to the currency chests located under its jurisdiction or in NCR of Delhi and;
  - (iii) Currency chests located under the jurisdiction of RBI, New Delhi (i.e., in NCT of Delhi) to any Issue Office of RBI.
- **3.3** All vehicles provided to the Bank should be GPS enabled having valid permit to travel locally and throughout India and all other statutory compliances in place. All vehicles shall be in good and proper condition with neat and clean upholstery.
- 3.4 The driver shall have a valid driving license, which should be produced by him as and when demanded by traffic personnel. Renewal of driving license from time to time shall be the sole responsibility of the Contractor. The drivers deployed shall have reasonable experience with good driving record, shall be well-mannered and should be able to converse in English, Hindi as well as Regional Language. He should be able to attend to the minor repairs of vehicles en-route, in case of need. The driver should provide mobile number to the Bank's representative / police escort on demand. The drivers must report for duty in clean uniform displaying their ID cards and at the specified time. They shall maintain a proper record of mileage on a daily basis and get the same authenticated by the user (Bank's representative / police escort). They shall maintain duty slips with complete details of kilometres travelled, time of reporting, time of releasing, meter readings at the time of start and end of journey etc. duly authenticated by the officer's signature. Besides they shall be neatly dressed and be polite, courteous and service oriented, at all times.

- 3.5 The drivers/employees engaged by the Contractor shall abide by the instructions provided by the security officers/guards of the Bank and vehicles/persons shall have to undergo security checks, as and when required. The driver shall always be available at the place where the car is parked and strictly follow all traffic rules. The driver shall carry a placard containing particulars of the arriving Bank's representative / police escort at the Airport/ Railway Station, etc. The Contractor shall ensure that there is no room for complaints from the Bank's representative / police escort. The drivers shall carry out the orders given by the authorized officers of the Bank and shall also observe the rules and regulations regarding safety and security. The vehicles shall be provided with branded (viz. Bisleri, Kinley, Aquafina, Himalaya, etc.) two Mineral Water bottles of 500 ml each every day during booking of Cars/Utility Vehicles, first-aid box, universal mobile charger, umbrella and fire-extinguisher. No extra charges shall be paid by the Bank for the same. The cost of items such as Mineral water, face tissue paper, first-aid box, etc. shall not be paid extra and will be borne by Contractor.
- 3.6 All protocol as prescribed by Central/State governments/Authorities from time to time with respect to COVID-19 pandemic or any other safety measures must be adhered to strictly.
- **3.7** All Graded Response Action Plan (GRAP) guidelines as prescribed by State Government/ Competent Authorities from time to time with respect to air pollution or any other safety measures must be adhered to strictly.
- 3.8 All the valid papers viz. comprehensive insurance, registration, road tax, pollution under control certificate, permits, valid license, etc. related to each vehicle shall be readily available in each of the vehicles/with drivers. The Contractor shall have ability to arrange emergency transport/touring facility providers, in case of breakdown of a vehicle provided to the Bank and should also be able to liaison with Govt. /Insurance agency arranging for emergency transport/touring facility providers, in case of breakdown of a vehicle provided to the Bank authorities. Alternate vehicles shall also be arranged immediately, in case of break-down.
- 3.9 The Contractor shall provide Cars/Utility Vehicles on written or verbal instructions over phone/E- mail within the time specified therein. The Contractor shall also be required to provide Cars/Utility Vehicles on short notice from the Bank (say within 30 minutes in case of emergency). The Contractor shall ensure that the Cars/Utility Vehicles provided are well maintained, without

dents/scratches and are not old. The Contractor shall ensure that the vehicles provided are registered and comply with the Motor Vehicle Act as amended from time to time. The Contractor shall arrange to obtain Police Verification certificate regarding the antecedents of the persons/drivers engaged by them. The Contractor shall convey (by e-mail /sms) without fail the confirmation of booking to the Issue Department of the Bank and to the Bank's representative / police escort followed by e-mail /SMS of car details i.e. Car make, Car Registration No., Driver's Name and mobile number to the Issue Department of the Bank and to the Bank's representative / police escort at least four hours prior to the time specified in the requisition.

- 3.10 Toll and parking charges shall be extra only for outstation trips based on production of original receipt. The persons engaged by the Contractor shall be the workers of the Contractor and neither the Contractor nor the labourers, shall have any right to claim any employment in the Bank. If the Contractor provides on his own any other make or model of car higher than the one requested, the payment shall be made according to the rates approved for a car requisitioned by the Bank. Contractor will make vehicles available from / at any other place in Delhi.
- **3.11** Contractor shall indemnify the Bank for any loss or damage that occurs to third party (persons or building, etc.) and/or to the Bank's representative / police escort, property of the Bank on account of hiring of car/ Cars/Utility Vehicles hired during the period of Agreement. The Bank reserves the right to recover the amount of loss and/or damage from the bill or Performance Bank Guarantee of the Contractor.
- **3.12** It shall be the sole responsibility of the Contractor to provide Cars/Utility Vehicles as and when requisitioned by the Bank including Night/Early Morning.
- 3.13 For deficiency in services and serious inconvenience caused to the Bank's representative or police escort or to those for whom Bank directs to provide services, penalty as explained below for the relevant instance will be imposed. The decision of the Bank regarding imposition of penalty will be final and the Contractor will not challenge the decision of the Bank in this regard. Recovery of the penalty will be done by way of deduction from the relevant bill, other pending bills or from the security deposit.
- (a) ₹2000/- will be levied in case of late reporting.

- (b) ₹2000/- will be levied in case wrong/ inflated entry is observed by the Bank in the Duty Slips relating to time/ Km.
- (c) ₹2000/- in case the driver stops for refilling fuel during duty.
- (d) ₹2000/- in case the Contractor did not make alternate arrangements within one hour in case of breakdown of its vehicle(s). The Contractor will be responsible to compensate all expenses incurred by the bank in this regard and the same will be deducted from the bill of the Contractor. Decision of the Bank in this regard will be final and binding on the Contractor. Such compensation may be in addition to any penalty imposed as mentioned above. Penalty and compensation, if any, will be deducted from the relevant bill, other pending bills or from the security deposit.
- (e) ₹5000/- will be levied in case driver is found/ reported to be under the influence of alcohol/ drugs, or any other illegal substance.

Bank reserves the right to impose penalty for any of the deficiency/ service lapse/ loss to the Bank not mentioned but is covered in Part I of the tender document. In case of more than one deficiency is reported in a single duty, Bank reserves the right to levy penalty for all such deficiencies. The decision of the Bank is this regard will be final.

- **3.14** In case of dispute, an appeal can be made to the Regional Director, RBI, New Delhi whose verdict shall be final in the matter and binding on both the parties.
- 3.15 Subject to other provisions of this agreement, the Bank hereby enters into agreement with the Contractor/s for a period beginning from April 01, 2025 and valid till March 31, 2026 for provision of Cars/Utility Vehicles on hire as per rates mentioned in Price Bid which can be extended by the Bank at its opinion for a further period of two years, one year each at a time with / without any variation in the terms and conditions, subject to satisfactory performance of the contractual terms and conditions and also subject to annual review by the Bank based on the performance of the Contractor /s.
- **3.16** The Contractor agrees to strictly abide by Broad Scope of Work and Guidelines as above while providing Cars/Utility Vehicles to officers/staff and guests of the Bank.

NOW IT IS MUTUALLY agreed and declared as follows:		
Commencement / Renewal		
This AGREEMENT is made for a period of one year	r from April 01 2025	to March 31, 2026

2. The terms and conditions of tender No d	ated	shall be regarded
as part and parcel of this Agreement and are not repe	ated herein for the sa	ake of brevity.

3. This agreement is renewable for further period of two years, as per Bank's discretion, with/

without any variation in the terms and conditions, subject to satisfactory performance of the Contractor.

4. When the period of the contract is about to expire, the matter of extension of the contract may be considered by the Bank. Three months before the expiry of the existing contract, the contractor shall provide in writing to the Bank, whether he is willing to renew the contract for a further period on the existing terms and conditions.

#### **Security Deposit / Performance Bank Guarantee**

The tenderer(s) shall furnish to the Bank an irrevocable Performance Bank Guarantee(PBG) from a scheduled commercial bank for a sum of ₹67,600/- in favor of the bank.

5. The performance Bank Guarantee (PBG) shall be for the due performance of the contract for the entire contract period also against any loss or damage caused to or suffered or would be caused to or suffered by the Bank. If the contract is renewed, the contractor will arrange to provide extended Bank Guarantee accordingly.

#### **Duties of the contractor**

- 6. It shall remain the contractor's responsibility to successfully execute the contract till the completion of validity period. In case contractor fails to carry out the assigned work, his/her PBG shall be invoked. Further, the contractor has to indemnify the Bank from any type of loss due to any negligence on its part and for which the Bank is not responsible.
- 7. The Contractor shall, at all times during the Contract Period, on the receipt of written or verbal requisition to that effect from the General Manager / Deputy General Manager, Reserve Bank of India, Issue Department, New Delhi or any of his subordinate officer(s), supply adequate number of vehicles for Police escorts for accompanying remittances. Such requisition may be delivered to the contractor by means of telephone or mobile phone or e-mail or fax etc. The requisition notice may be cancelled by the Bank by issuing another notice, orally or in writing not less than three hours before the time fixed for transport of note boxes. In such case the Bank shall not make any payment to the contractor by way of remuneration compensation etc.
- 8. In urgent cases, certified by the General Manager/DGM-in-charge, Issue Department of the Bank, requisition with thirty minutes notice in lieu of twelve hours' notice, may be made by the

Bank and shall be complied with accordingly by the contractor.

- 9. The notice so given shall be complied with, even if it requires working beyond ordinary business hours or on a day / days declared as Public Holiday/s under the Negotiable Instruments Act, 1881 including Saturday and Sunday or any other extant statute / provision applicable in this respect.
- 10. The contractor shall not, in any circumstances, travel any other person in the vehicles other than Bank representatives and Police Escorts.
- 11. The tenderer shall be required to obtain necessary route permits and pay all relevant taxes on his/her own.
- 12. It should be duty of the Contractor to issue uniforms/ photo identity card to his drivers.
- 13. The contractor shall not assign the contract onwards. He/She shall not sublet any portion of the contract except with the prior written consent of the Bank. In case of breach of this condition, the Bank may rescind the contract and invoke PBG.
- 14. In case of any breakdown of vehicles, the contractor shall be able to provide services of alternate Cars/Utility Vehicles of similar specifications so that the remittance of the treasure is not delayed. In case the contractor fails or delays such arrangement and the Bank makes such arrangement from market, the Bank shall be entitled to recover the cost of such arrangement from the contractor from the charges/bills to be paid to the contractor.
- 15. The contractor shall ensure that the vehicles are having valid permission issued by RTO concerned, Registration papers, permit, PUC certificate, Fitness Certificate, tax paid up to date, required Insurance cover, etc. to the vehicles. The drivers must have valid driving license. The contractor will indemnify and keep the Bank indemnified against any loss, costs, charges and expenses incurred or suffered by the Bank on account of lack of said permit, license, certificates, etc. The contractor shall ensure adherence to all state government/central government instructions/guidelines w.r.t vehicles being provided which inter alia includes adherence to GRAP norms/ban on plying of diesel/petrol vehicle of prescribed age etc.
- 16. The Bank shall have the right to inspect or arrange inspection of the vehicles deployed by

the contractor for the work at any time and declare any vehicle/ equipment unsafe and ask for its immediate withdrawal from the operation. The contractor shall ensure prompt/ immediate compliance of the same.

- 17. The vehicles supplied by the contractor shall be less than 5 years old and must be roadworthy and in good condition. These vehicles shall either be owned or leased by the contractors. In case of leased vehicles, the lease of vehicles shall not expire during the contract. Full set of spares and tool kit must be available in the vehicle. The vehicles should be covered by insurance, with all taxes paid and with valid permits. The final decision as to whether the vehicles meet the said requirements will be that of the Bank which will be binding on the contractor.
- 18. The work of the Bank should be carried out in a proper, careful, expeditious and efficient manner. The tenderer shall be required to work in close co-ordination with the Delhi police.
- 19. The operations to be entrusted to the Contractor will be time-critical. Therefore, the contractor should supply sufficient and adequate number of vehicles at such notice as may be specified by the Bank.
- 20. Drivers must have sufficient funds for refueling, toll fees, etc. and for minor repair enroute, if necessary. The vehicles will stop for refueling etc. at places only with the approval of police Escort in charge. It should be ensured that fire extinguisher and first aid are available in the vehicles.
- 21. It is imperative on the part of the Contractor to get antecedents and character of all the drivers engaged by him verified by the Police Department before the commencement of the contract. The drivers should possess valid driving license. Copies of driving license and other documents and verification of the antecedents shall be submitted to the Bank. Drivers should be polite, courteous and service oriented at all times. Drivers shall not do drink and smoke while carrying out the duty of the Bank.
- 22. The contractor shall ensure that the Vehicle sent to accompany the closed trucks carrying remittance of notes/ coins reach simultaneously with the trucks at all the specified destinations.
- 23. The contractor will adhere to the relevant provisions of IS policy of the Bank.

#### **Payments and Taxes**

- 24. The payment will be made on monthly basis after the submission of bills for each consignment complete in all respects.
- 25. The contractor shall be paid charges for services rendered at the rates mentioned in the Schedule to this Agreement. The said charges offered are fixed and cannot be enhanced on any ground for the entire contract period and no additional charges shall be claimed by the contractor.
- 26. Distance covered for payment of bills for any place will be determined as per record available with the Bank and duty slips with complete details of kilometres travelled, time of reporting, time of releasing, meter readings at the time of start and end of journey etc.
- 27. Bills for the services may be submitted on monthly basis and will be paid after rounding off the final amount to the nearest rupee. Payment will be made after deducting Income Tax and Surcharge at source, any Tax etc., if any levied by the Central/State Government will be borne by the contractor. In case of disputed bills, adjustment will be made after mutual negotiation/arbitration.
- 28. The contract price shall be all inclusive consisting of fixed and operating charges and based on the Scope of Work, vehicle being supplied and also include inter alia, Driver's salary/uniform/food/allowances etc., Employees' State Insurance Corporation (ESIC) payment, Employee Provident Fund (EPF) payment, Bonus payment, Gratuity, insurance, profit & overtime wages, if any, taxes & levies, parking charges, toll gate fees & all other charges. It is obligatory on the part of the Contractor to pay wages which should not be less than minimum wages as prescribed by the appropriate authority under the Minimum Wages Act, to his contract labour, retrenchment compensation, notice pay, gratuity and bonus as payable and the Contactor is liable to provide all welfare measures to the contract labour as required by the prevailing laws in this regard.
- 29. The Bank reserves the right to recover/enforce recovery of any overpayments detected after payment as a result of post-payment audit or technical examination or by any other means.
- 30. All compensations or other sums of money payable by the contractor to the Bank under

the terms of the contract shall be deducted from the dues payable or becoming payable to the contractor or by invoking the Performance Bank Guarantee as deemed fit by the Bank.

31. In the event of any dispute as to whether any liability has arisen hereunder, the decision of the Regional Director/Office-in-charge, Reserve Bank of India, New Delhi shall be final and binding on both parties. For all types of litigations arising under the Contract, Delhi Courts will have exclusive jurisdiction.

#### Insurance

32. The contractor shall take all insurances at his cost to cover all kinds of risks associated with the vehicles/third party. These policies shall be valid for the accepted contract period. If the Contractor does not provide these policies, the RBI reserves the right to take the above insurance policies themselves and recover the cost thereof from the bill of the Contractor.

#### **Disqualification / Termination/ Penalty:**

- 33. It will be treated as a serious misdemeanor in case a tenderer attempts to do any canvassing by or on behalf of the tenderer or to bring political or other outside influence with regard to the Bank's decision on scrutiny, comparison, evaluation and award of the contracts. In such case the tender of the tenderer shall be liable for rejection in addition to being blacklisted for a period of minimum one year extendable to 3 years. If such instances go undetected during the selection process but are detected subsequently, such disqualification will take place with immediate effect.
- 34. The contract may be terminated by either of the two parties for any reason, giving to the other party three months' notice in writing of such termination.
- 35. In event of any delay by the contractor in complying with any requisition issued by the Bank for supply of vehicles or any breach of instructions of the contract, considered by the General Manager/DGM-in charge, Issue Department, Reserve Bank of India, New Delhi to be grave enough to attract penalty, the aforesaid General Manager/DGM-in-charge in consultation with Regional Director/Officer-in-charge may impose a fine not exceeding Rs. 10,000 (Rupees ten thousand only) on the contractor for each instance.
- 36. In case of frequent or continued delay or in case of any breach by the Contractor of any

of the provisions of this agreement, the Bank may terminate this contract with immediate effect by giving intimation in writing by the General Manager / Deputy General Manager-in-charge, Issue Department with the approval of the Regional Director/Officer-in-charge on behalf of the Reserve Bank of India whether any penalty as herein before provided for such delay or breach has been imposed or not.

- 37. If at any time the Bank finds that through the default of the contractor or his workers owing to insufficiency or delay or failure or other defect in the supply of escort vehicles the treasure cannot be dispatched/received in due time it shall be open to the Bank to cancel the requisition and reject all the vehicles supplied on the occasion and get the work done in any other manner, making the contractor liable for any extra charges involved therein, irrespective of whether any fine is imposed or not.
- 38. Continuation of the contract shall be primarily depending upon the performance of the contractor. In case the performance is found to be unsatisfactory at any point of time, the contract shall be terminated by giving three months' notice in writing.
- 39. If the Contractor failed to provide services for more than 3 occasions continuously, then the Bank has right to terminate the Contract with/ without giving any notice whatever may be the reason. In such case the transporter has no power to claim compensation.
- 40. For deficiency in services and serious inconvenience caused to the Bank's representative or police escort or to those for whom Bank directs to provide services, penalty as explained below for the relevant instance will be imposed. The decision of the Bank regarding imposition of penalty will be final and the Contractor will not challenge the decision of the Bank in this regard. Recovery of the penalty will be done by way of deduction from the relevant bill, other pending bills or from the security deposit.
- (a) ₹2000/- will be levied in case of late reporting.
- (b) ₹2000/- will be levied in case wrong/ inflated entry is observed by the Bank in the Duty Slips relating to time/ Km.
- (c) ₹2000/- in case the driver stops for refilling fuel during duty.
- (d) ₹2000/- in case the Contractor did not make alternate arrangements within one hour in case

of breakdown of its vehicle(s). The Contractor will be responsible to compensate all expenses incurred by the bank in this regard and the same will be deducted from the bill of the Contractor. Decision of the Bank in this regard will be final and binding on the Contractor. Such compensation may be in addition to any penalty imposed as mentioned above. Penalty and compensation, if any, will be deducted from the relevant bill, other pending bills or from the security deposit.

- (e) ₹5000/- will be levied in case driver is found/ reported to be under the influence of alcohol/ drugs, or any other illegal substance.
- 41. Bank reserves the right to impose penalty for any of the deficiency/ service lapse/ loss to the Bank not mentioned but is covered in Part I of the tender document. In case of more than one deficiency is reported in a single duty, Bank reserves the right to levy penalty for all such deficiencies. The decision of the Bank in this regard will be final.

#### **Compliance with Statutes:**

- 42. The contractor shall abide by all relevant laws in force in the country and state(s) concerned. The contractor shall indemnify the Bank from all types of legal implications due to any negligence on their part and for which the Bank is not responsible.
- 43. The bidder must ensure adherence to various statutory provisions relating to labour, taxation, workmen safety, child and women labour, employment reservations etc. The bidder must be registered under appropriate authorities i.e must be registered with GST authorities/Income Tax/PAN/EPF/ESI authorities/Indian Registration Act 1908/Labour licence etc
- 44. The contractor shall abide by the provisions of the Motor Vehicle Acts and the rules of various States in force in the States concerned.
- 45. The Contractor should be registered under the Shop & Establishment Act and have necessary certificate to run tour & travel services. All the Cars/Utility Vehicles deployed by the Contractor for duty with the Bank's guests/officials should be of commercial nature i.e., they must be registered with the RTO as a commercial vehicle. Documentary evidence of Cars/Utility Vehicles permits shall be provided to RBI as and when demanded.
- 46. The contractor shall make all applicable statutory payments like Minimum Wages, Employee Provident Fund (EPF), Employees' State Insurance Corporation (ESIC), payment

of Gratuity under Payment of Gratuity Act, 1972 to their deployed Workmen(Drivers) as per the notification published by Central Govt. / State Govt. whichever is higher from time to time, besides paying all other statutory payments.

- 47. The workmen should be paid the minimum wages under the Minimum Wages Act, 1948 and rules made thereunder. Besides, the workmen should be given Employees Provident Fund as per EPF Act, 1952, Bonus and / or dividends as per Payment of Bonus Act, 1965 and ESI under ESI Act, as applicable. In the absence of ESI, the contractor should undertake the liability under the coverage of Insurance such as Workmen's Compensation Insurance under Workmen's Compensation Act, 1923. The total premium shall be borne by the contractor. The contractor shall have a valid EPF Account for making EPF Contribution for its workmen. In case of any complaint regarding non-compliance of any statutory payments; the same shall be deducted from the bill without prejudice to the Bank's right to cancel the contract. The Contractor shall abide by all the statutory provisions of the Contract Labour (Regulation & Abolition) Act.
- 48. The Contractor shall maintain all records and legal documents updated as per prevailing statute and have to produce before the management / statutory authorities as and when asked for.
- 49. The contractor shall submit the salary disbursement statements against the signature of its employees assigned for the Bank's work for verification by the Bank on quarterly basis. If payment is made in cash, it should be in presence of the Bank's official under his signature. Alternatively, employees' bank account may be credited and bank statements indicating payment may be submitted.
- 50. The Principal Employer i.e. the Bank shall not be responsible for providing any employment benefits to the contract labour/workers/employees. In the event of the Bank as the Principal Employer being required/called upon to pay any amount to the contract labour/workers/employees engaged by the contractor due to lapse or default on his part in discharging his obligation in terms of any law in force, such amount would be recoverable by the Bank from the contractor as debt due to the Bank by the contractor.
- 51. The contractor shall be solely responsible for full compliance of the provision of the Sexual Harassment at workplace (Prevention, Prohibition and Redressal) Act, 2013 by any mazdoor

or other persons deployed by him/her for execution of the contract. In case of any complaint of sexual harassment against its employees/labour within the premises of Reserve Bank of India, the complaint will be filed before the Internal Complaints Committee constituted by the contractor and he/she shall ensure taking proper action under the Act in respect to the said complaint. The contractor shall be responsible for educating its employees about prevention of sexual harassment at work place and related issues.

- 52. Any complaint of sexual harassment from any aggrieved employee of the contractor against any employee of the Bank shall be taken cognizance of by the Regional Complaints Committee constituted by the Bank.
- 53. The contractor shall be responsible for any monetary compensation that may need to be paid in case the incident involves the employees of the contractor, for instance any monetary relief to the Bank's employee, if sexual violence by the employee of the contractor is proved.

#### Non-Disclosure Clause:

54. The Contractor shall not disclose directly or indirectly any information, materials and details of the Bank's infrastructure/systems/equipment etc., which may come to the possession or knowledge of the contractor during the course of discharging its contractual obligation in connection with this agreement, to any third party and shall at all times hold the same in the strictest confidence. The contractor shall treat the details of the contract as private and confidential, except to the extent necessary to carry out the obligation under it or comply with applicable laws. The contractor shall not publish, permit to be published, or disclose any particulars of the works in any trade or technical paper or elsewhere without the previous written consent of the Bank. The contractor shall indemnify the Bank for any loss suffered by the Bank as a result of disclosure of any confidential information. Failure to observe the above shall be treated as breach of contract on the part of the contractor and the Bank shall be entitled to claim damages and pursue legal remedies. The Contractor shall take all appropriate actions with respect to its employees to ensure the obligation of non-disclosure of confidential information under this agreement is fully satisfied. The contractor's obligations with respect to non-disclosure and confidentiality will survive the expiry or termination of this agreement for whatever reasons.

#### **Workmen Safety and Insurance**

- 55. The contractor shall alone be fully responsible for safety and security and insurance or life insurance of deployed Workmen (Drivers)
- 56. The Bank shall not be liable for any compensation in case of any fatal injury/death caused to or by any manpower while performing/discharging their duties/for inspection or otherwise.
- 57. The quoted rates shall not be less than the minimum wage fixed/notified by the state Government and shall include all statutory obligations.
- 58. The contractor shall be liable for all kinds of dues payable in respect of all personnel provided under the contract and the Bank shall not be liable for any dues for availing services of the personnel.
- 59. The contractor shall ensure that persons to be deployed are not alcoholic, drug addict and not indulge in any activity prejudicial to the interest of the Bank. The contractor shall ensure to get the police verification for all the manpower deployed by them and the contractor should ensure that the manpower deputed should bear good moral character.

#### **Dispute Resolution**

- 60. It is to be duly noted that in case of any / all disputes on terms and condition of this tender, the English version of the tender document shall prevail (in case tender is issued in English and any other language simultaneously).
- 61. If a dispute of any kind arises between the Bank and the contractor/counterparty in connection with or arising out of the contract or the execution of the works, the parties must attempt to resolve it amicably by way of mutual discussions, in good faith, within a period of 30 days from the date on which any party gives the other party a notice to negotiate/engage in amicable discussions.
- 62. If an amicable settlement is not forthcoming within the aforesaid period, then the dispute shall then be referred to and finally resolved through arbitration or conciliation as per the Arbitration and Conciliation Act 1996, as amended from time to time. The award passed by the arbitrator shall be binding on the parties and shall apply to the contract.

63. Jurisdiction and Governing Law: The agreement shall be subject to the jurisdiction of the

courts at Delhi. The agreement is governed by the laws of India

**Agreement Commencement and Execution** 

64. The provisions of this Agreement and the rates shown in the enclosed schedules are

effective from April 01, 2025.

65. This Agreement shall be executed, in duplicate, the original shall be kept with the Bank

and the duplicate by the Contractor.

66. In the event of discrepancy between the two versions, the English version would be

treated as the authentic one and prevail over the Hindi Version.

67. There will be no increase in the contract amount during the currency of the Agreement.

68. The Bank shall have the right to reduce the rates given in the schedule, to the extent

deemed appropriate by the Bank, if through any changes in technology and/or extant

practices or through any other factor, the quantum of work carried out by the Contractor under

this agreement is either directly or indirectly reduced or is required to be reduced as per

decision of the Bank.

69. All the terms and conditions as mentioned in the Tender Notice shall be treated as part

and parcel of this agreement and shall be binding on the contractor.
